

## Census 2000 is Underway

On March 13, 2000, the US Bureau of the Census mailed the Census 2000 questionnaires to all households across the United States. The Census questionnaire is used to count every person living in your home or apartment and includes people of all ages, citizens and noncitizens. **You** are needed to make this census a success.

Census 2000 is your chance to make sure the new century begins with an accurate and complete picture of Hanover Park. Your answers are important. The number of people living in the State of Illinois will determine the number of representatives each state has in Congress. Billions of dollars of Federal, State, and Local funds and how they are allocated to neighborhoods depends upon your answers. This money will be used for schools, employment services, housing assistance, roads, services for children and the elderly, and many other local needs. It is important that **all** Hanover Park residents are counted so the Village gets its fair share of Federal, State, and Local funds.

The Census Bureau is strongly committed to confidentiality. The answers you provide to the questions on the Census form and your privacy is protected by law. Title

13 of the United States Code mandates that **no one** outside the Census Bureau can ever give any information that would enable them to connect your answers with your name and address. Title 13 also requires that you answer the questions on the Census form. If there are violations of this law, a Census Bureau employee is subject to a \$5,000 fine and five-year prison term.

The Village requests you participate in Census 2000 and send back your census form by April 1, 2000 which is the National Census Day. Taking part in the census is in everyone's best interest. If you need help completing the Census form, call 1-800-471-9424, between 8:00 AM and 9:00 PM, seven days a week. This telephone call is free. Please remember it costs eight times as much to send a census enumerator out to your home to get your census information and answers than it does to mail back your census form.

### Mayor Irv Bock

Several months have passed since I provided an update on the disconnection of the Hanover Park Fire Protection District. The Village continues its legal battle now at the Appellate Court level.

Although the majority of the Fire Protection District Board voted, on February 16, 2000, to withdraw its appeal, two remaining Board members continue to oppose the District's decision to drop the appeal.

The Appellate Court has decided NOT to hear oral arguments regarding the appeal; therefore, a decision should be forthcoming in the next few months.

During the interim, the Fire District Board and the Village Board continue to work together preparing for the eventual transfer of services from the District into a

Village Fire Department. Both Boards are cooperatively exchanging information so that the Village can prepare for a seamless transition, particularly as it relates to budget topics.

The Village and the new Fire Protection District Board are working together to ensure you, the residents, obtain the best service for your tax dollar. Fire District vehicles are now refueling at the Village pumps, saving your money. The Fire District and the Village of Hanover Park are also working together to evaluate all fire equipment and will eventually review the buildings and all other Fire District assets.

In the spirit of cooperation, the Fire District just completed CPR training for Village staff, including police personnel. This training is particularly valuable as it will allow Village staff to better respond to emergencies until paramedics arrive. This training will become part of an ongoing training program available to all Village employees.

Currently, the Village is in the process of reviewing the Fiscal Year 2001 budget that will take effect, May 1, 2000. When the Court decision regarding the appeal is final, the Fire District

budget will be incorporated into the Village budget. Subsequently, a "year of review" will take place, in which the Village will review all aspects of Fire Department operations.

The Village of Hanover Park has the expertise to evaluate all of the fire department as it pertains to areas of labor relations, equal opportunity employment practices, budgets creation and control, organizational development, planning, and administrative practices. This evaluation will ensure that residents are provided with the best fire protection service available.

## In the News

### Victory at Last... Court Ordered Twin Spa to Close

The Village recently won a legal decision against the Twin Spa massage parlor located on Irving Park Road. After more than two years of litigation, a Cook County judge ruled Twin Spa was an illegal adult use business and ordered the establishment closed.

Twin Spa had opened without Village approvals and provided services that are not permitted in the Village's B-2 Local Business District. The Village filed a lawsuit claiming the business violated the

Village's adult use zoning ordinance and did not properly obtain a business license prior to opening.

Adult use zoning ordinances are complex, legal documents. Recently, courts have prohibited villages from outright prohibiting adult uses. Rather, municipalities can restrict adult use businesses to designated zones. The Village amended its ordinance to assure it passed constitutional muster. The Village did not want an adult use

establishment on a heavily traveled roadway, like Irving Park Road, in a retail zoning district.

Judge Albert Green said, "The Village of Hanover Park has established a ... clearly ascertainable right that needs protection – the right to attempt to preserve the quality of life by application and enforcement of its zoning laws." The Village Board aggressively fought the adult use business in order to preserve its family-oriented community image.

### "Adding Fuel to the Fire" ... Department

On March 13th, Village Officials and Fire District staff celebrated a "Ceremonial Fuel Up" of one of the Fire District's engines at the Village fueling station behind Village Hall. This act was significant as it represents the spirit of cooperation between the District and the Village. An Intergovernmental Agreement between the Village and District Boards regarding fuel usage took effect on February 17th.

Mayor Bock joined Fire District President Rod Craig, Fire Chief Dick Parker, Lt. Tom Hite and Firefighters Jim Hite and Keith Rominski for a "Ceremonial Fuel Up" of a Fire Department fire engine at the Village fueling station on March 13th.

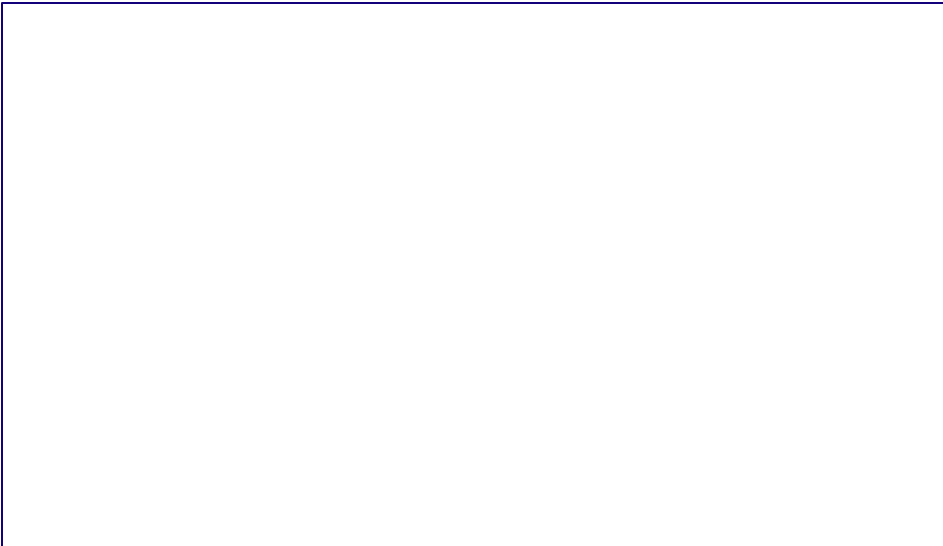

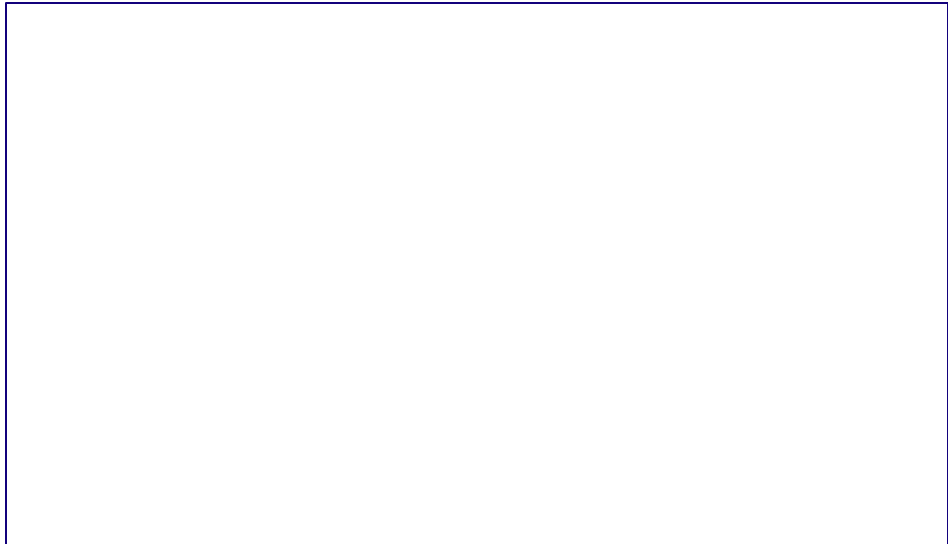

### STEP Program Achieves Goal

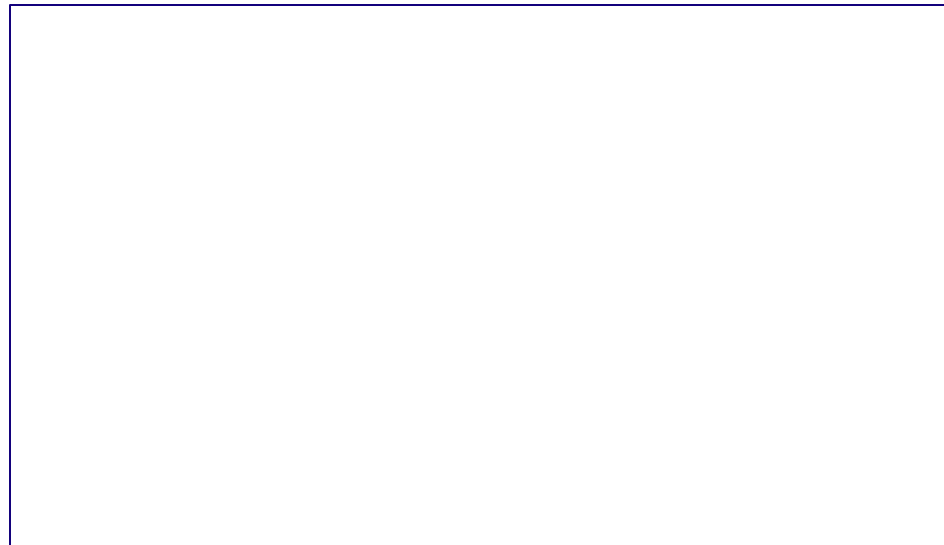
One of the 1999 goals for the Police Department was to reduce traffic accidents on public roadways by 5% of the average of the years 1996-98. This three-year average was 1,218 per year.

To reach the reduction objective, the Police Department initiated the STEP Program (Selective Traffic Enforcement Program) which began in July 1999 and continued through December 1999. The first step was identifying the most problematic intersections in the Village: Barrington Road and Lake Street, Barrington Road and Irving Park Road, and Army Trail and County Farm Road. These three locations represent the most congested intersections in the Village. The Police Department concentrated efforts on reducing accidents at these locations to reduce the total accident rate. To accomplish this goal, efforts were focused on education and enforcement.

The results of the STEP Program were successful. Traffic accidents on the public right-of-way were recorded at 1,154, reflecting a reduction of 5.25%

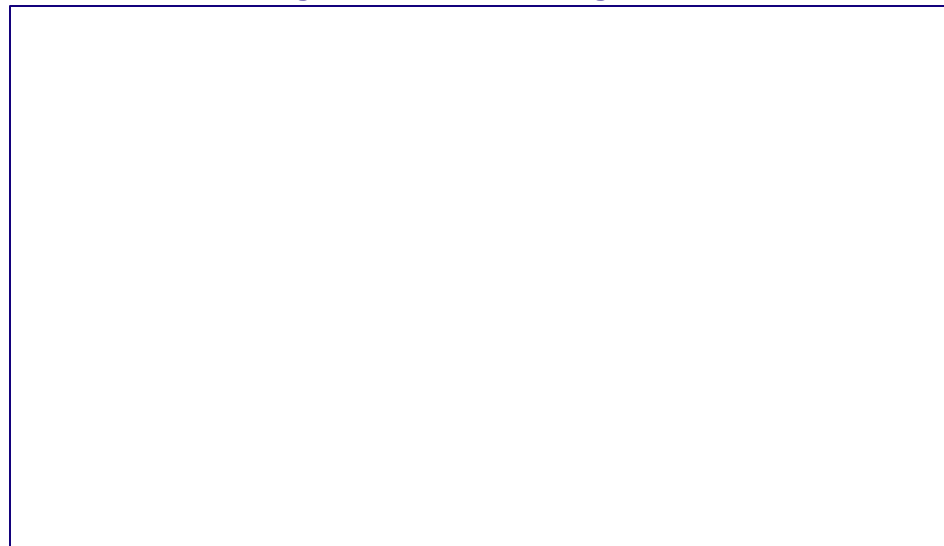
In 2000, the Police Department will continue the STEP Program to further reduce traffic accidents.

### Police Officer Assists in Delivery of Baby Girl

### Police Officers Recognized for Outstanding Service

The officers were commended for their actions on January 29th when they arrested a subject who had been involved in a domestic violence situation and had threatened to harm himself. ## Police Department News

### Major Crime Decreases 27% in 1999

In 1999, the Hanover Park Police Department recorded 863 total Part I crimes. Part I crimes are the eight crimes that are reported to the FBI and are listed in the Uniform Crime Reports which establish a jurisdiction's crime rate. These crimes include murder, rape, robbery, aggravated assault, burglary, theft, motor vehicle theft, and arson. 1999 shows the lowest number of Part I crimes reported since we began reporting in 1974. This number translates into a rate of 2,426 crimes per 100,000 population.

Nationwide and Illinois crime rates are not yet published for 1999; however, this rate of 2,426 for 1999 compares quite favorably with a 1998 nationwide rate of 4,615 and an Illinois statewide average crime rate of 5,048 per 100,000 persons.

This reduction of 316 cases from 1,179 in 1998 to 863 in 1999 reflects a 27% reduction in Part I offenses.

### Sergeant Brian Roper Graduates from Northwestern University Traffic Institute

Sergeant Brian Roper recently graduated from Northwestern University Traffic Institute's School of Police Staff and Command (SPSC). The ten-week SPSC is designed to prepare top- and mid-level law enforcement managers and supervisors for senior agency positions.

Sergeant Roper attended the 136th class, which was hosted by the Northeast Multiregional Training Board in Elmhurst. The session ran from September 13, 1999 to January 21, 2000.

The SPSC program covers four broad areas of study; management and its environment, organizational theory and behavior, human resource administration, and skills for planning and analysis. More than

5,000 officers from state, county, and municipal agencies have taken advantage of the program since its first session was held in 1983.

The Traffic Institute was established at Northwestern University in 1936 for the purpose of expanding the scope of university-level education and training in traffic safety. Since that time, the institute has broadened its original objective to include training in police operations and management.

Sergeant Roper has been a member of the Hanover Park Police Department since October, 1984 and has held the rank of Sergeant since January, 1993. Currently, Sergeant Roper is shift supervisor for the evening shift which includes supervision of patrol officers and the tactical unit.

## Development News

### FujiFilm coming to Hanover Park

FujiFilm America is coming to Hanover Park! FujiFilm will be constructing a 300,000 square foot building, including 80,000 square feet of office space, at the southwest corner of Gary Avenue and Central Avenue in the Turnberry Lakes Business Park. This new facility will bring several hundred employees into the community, and Fuji expects to train thousands of people throughout the year at this location.

The new facility will house Fuji's regional headquarters and will feature a very attractive glass façade facing Central Avenue and Gary Avenue, which will be one of the first buildings people can see as they enter the Village driving south on Gary from the Elgin-O'Hare Expressway. The facility will also include a large-scale warehouse and distribution operation at this site.

Site work for the project is already underway on the approximately 22-

acre site at Gary and Central. The developer for the project is Industrial Developments International (IDI) based in Oakbrook Terrace. IDI is working with Village officials to secure the necessary approvals for this project, which should begin construction in the Spring.

### Hanover Car Wash to Expand

The Hanover Car Wash at 1325 Irving Park Road will be expanding to include a 2800 square foot addition. The addition will double the size of the building to about 5650 square feet. The owner plans to expand the facility to include more mechanized cleaning equipment, additional floor space for the auto detailing area, and addition of a customer waiting room and office area. The project obtained Village Board approval for the expansion on Thursday, March 2.

The owner will be adding new shrubs, trees, and other site enhancements. Also, the entire building façade will be refinished to present a more contemporary appearance.

## Village Host Seminar for Local Realtors

The Hanover Park Economic Development Committee sponsored a **Realtor's Luncheon & Seminar** on Thursday, March 9th at Village Hall.

The seminar provided information on the many benefits of living in Hanover Park and included five key speakers: Mayor Irv Bock, Economic Development member Brad Gamss, Hanover Park Police Chief Ron Moser, Principal Cathy Ratcliffe of Elsie Johnson Elementary School (School District 93), and

John Said, Hanover Park Director of Community Development.

Brad Gamss, owner of Rahl Jewelers and member of the Village Economic Development Committee, acted as Master of Ceremonies. Mr. Gamss discussed his experience doing business in Hanover Park and introduced the three key areas addressed in the seminar: public safety, education, and development projects.

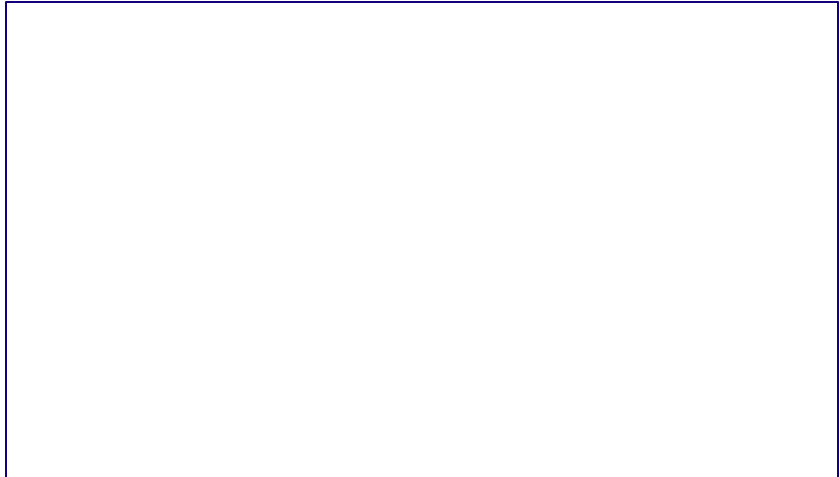

### Multicultural Event

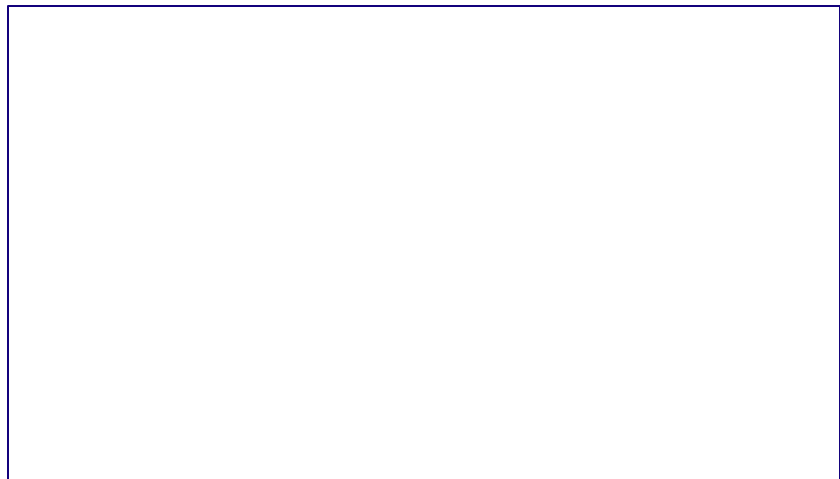

## Hydrant Flushing Begins in April

Starting Monday, April 10th through April 20th, the Village Water Division will be flushing hydrants throughout the Village. The flushing will occur between the hours of 7:15 AM and 2:45 PM. Notices will be posted in designated areas prior to flushing.

Please **DO NOT WASH LAUNDRY** during the flushing hours as rust stains may result. Residents with water softeners are encouraged to check the cycle time of their softeners so that the unit does not regenerate during this period.

The Village flushes hydrants for several reasons, including:

1. Flushing improves water quality by removing minerals such as iron and magnesium that have collected in the water mains.
2. Flushing improves water flow;

by removing minerals, the diameter of the water main is increased.

3. Flushing allows for the hydrants to be inspected and properly maintained, essential in the event the hydrant is needed in an emergency.

The schedule for hydrant flushing by area will be as follows:

### Cook County

#### April 10, 11, & 12

South of Irving Park Rd., north of Lake St., west of Barrington Rd.

#### April 13

South of Irving Park Rd. and east of Barrington Rd. (Hanover Highlands and Longmeadows South areas).

#### April 14, 17, & 18

Jensen Blvd. east to Farmstead Ln., north of Irving Park Rd. to Cynthia Ln. and Hastings Ln.

### DuPage County

#### April 10, 11, 12, & 13

South of Devon, east of Church Rd., west of Arlington Drive East (Greenbrook, Fremont, and Glens areas.)

#### April 14 & 17

South of Stearns Rd., north of Schick Rd.

#### April 18, 19, & 20

South of Schick Rd. to Army Trail Rd., east of Bayside Dr. to west of Kuhn Rd., and west of Windjammer Ln.

**This schedule is subject to change due to weather conditions or emergencies!**

## April Brush Pickup Program Begins

The Village Brush pickup program will begin April 3rd. In the event that this Hi-Lighter does not reach you prior to your scheduled pickup date, please **do not** set your brush out. You can either utilize BFI yardwaste collection or wait until the next Village brush collection in July.

Please refer to your Solid Waste Services Newsletter for additional information. Questions regarding the Village brush collection program should be directed to the Public Works Department at 372-4440.

### What will be picked up:

- Branches that are at least two feet long, no more than ten feet

long, and less than eight inches in diameter.

### What will NOT be picked up:

- Small hedge or pine clippings.
- Yardwaste or brush in containers.
- Brush or branches with thorns.
- Stumps or tree roots.

### How to stack the brush:

- Neatly stack the brush in one direction with the butt end toward the street.
- No lumber, wire, rope, or other material may be included with the brush.
- Do not block the sidewalk when putting brush out!

### Set-out Time

Brush can only be set out two days prior to 7:00 AM on your

pickup day. **Please do NOT put brush out after 7:00 AM on the first day of the collection cycle. Hold it for the next scheduled pickup.**

### April 3rd

Area 1: Streets north of Lake St. and west of Barrington Rd.

### April 10th

Area 2: Streets north of Lake St. and east of Barrington Rd.

### April 17th

Area 3: Streets south of Lake St. and north of Lawrence Ave.

### April 24th

Area 4: Streets south of Lawrence Ave.

BFI resumes regular yardwaste collection on Friday, April 7th, 2000.

### Free Wood Chips!

The Village will deliver loads of wood chips, a by-product of the Village's brush pickup program, to residents free of charge.

Each load will average about four cubic yards—enough to fill an area six feet by six feet by three feet high (6' x 6' x 3'). The Public Works Department will deliver the wood chips and will dump them in the driveway only. Wood chips will not be dumped on driveway aprons, sidewalks, or lawns.
